Following a prayer offered by Larry Sinclair, a meal of Salisbury Steak, Mashed Potatoes, Corn, Rolls and Brownie Dessert was enjoyed by all. Preceding the opening of business, a moment of silence was devoted to members who passed away during the last year. Those honored were Betty Miller, Margaret Austermilller and Jack Slagle.

Jerri Osborn then gave a report from the Henry County Retired Teachers Foundation. The members met on February 27, 2014. Steve Seagrave was welcomed as a new member of the board. A report from the Foundation and an updated history of recipients may be found in the March newsletter. It was reported that audits of the Foundation are to take place every two years, with one scheduled for 2014. Handouts are available for the scholarships and will be sent online to HCRTA members. All members are asked to think of possible candidates for the scholarships and to encourage them to submit applications for the appropriate scholarships by the due dates of April 1 and June 1 respectively.

Pros and Cons on buying Long-Term Care

First, the data-

In Ohio, average cost of nursing home care is \$5,000/month (\$60,000/year)

In Ohio, assisted living costs average \$3920/month

In Ohio, home healthcare averages \$18/hour (more on weekends & holidays)

Average stay in a nursing home is 835 days (2+ years)

At least 70% of people over age 65 will require some long-term care services at some point, more than 40% will need care in a nursing home.

67% of people who planned to have someone help with care haven't asked; one in five caregivers said they are "not at all prepared".

Other factors: Do you live a healthy lifestyle? If yes, you are often the type who need long-term care because you live longer, but often with a need for assistance.

How will long-term health care needs affect your family? A pro for long-term care insurance is that it reduces the burden of care that may otherwise fall on loved ones.

Are you willing to spend your own assets down and then become a dependent of the state?

A policy can alleviate this issue.

Can you afford a premium that would provide you a reasonable amount of coverage? Policies come in many forms- some basic and others with many more extras. A basic plan for a 65 year old would cost approximately \$3000 per year (\$250/mo.). Some plans qualify for tax deductions.

Due diligence – do your homework before purchasing a plan. There are some unscrupulous insurers who try to take advantages of your situation. Use only highly rated insurers with good fiscal standing. Get a lot advice before purchasing.

The Pros of long-term care insurance are that it allows you to maintain your independence and reduces the financial & psychological stress that a long term care need causes a family.

The cons are the cost of the premiums and the policies are often complex.

Some concern was expressed over Aetna Insurance replacing Blue Cross/Blue Shield. After the meeting the members drove to the Campbell Soup Company Plant for a tour of its facilities.

30 years ago:

A dinner meeting was held at St. John's United Church of Christ, Holgate, in May of 1984, with sixty-four HCRTA members and guests attending. District Director Earl Farber urged members to give full cooperation with AARP on all issues pertaining to legislation. The program for the evening was presented by Mary Fran Meekison on the history of education in the one room school.

20 years ago:

New members Barb Hoffman, Lois Young, and Margaret Austermiller were welcomed at the May HCRTA meeting held at the Holiday Inn. Treasurer Margaret Mueller reported a balance of \$3,808.63. Legislative Chairman Martha Potter reminded members of the need to send cards to Washington D.C. concerning health care. Jim Kieffer, ORTA District Director, spoke on Bill 207 and the need for retired teachers to have adequate representation on the State Retirement Board. A musical program by Mark Schnitkey and Peg Snyder followed the luncheon.

10 years ago:

The HCRTA May meeting was held at the Napoleon American Legion Hall. It was reported that 11 members had attended the District 1 meeting in Perrysburg. In legislative news Becky Schindler re-

ported that we do not support "Buy Ohio" at the levels proposed in H.B. 227." "Buy Ohio" requires that all or most of our pension be invested in Ohio businesses and these investments were very weak at the time. After dinner Chris Lankenau entertained the members with a program titled "Susie Homemaker and Her New 1954 Kitchen." Ms. Lankenau took us down memory lane to "The 50's" as we conjured up images of the kitchen appliances and colors of those years.



5 years ago:

The Henry County Hospital was the site of the May 2009 HCRTA meeting. Bonnie Eddy announced that Gene Grime's 2008 third grade dictionary project was recognized by NRTA-AARP for a Chapter Community Service Award. Ohio received five of the fifteen nationwide awards. Al Baldwin, Regional Manager of the Ohio Lottery Commission, was the speaker for the evening. Ohio schools receive about 29 percent of the lottery receipts. The Ohio Lottery began in 1973 and although the lottery provides much money to education, the receipts represent less than 5 percent of education expenses.

1 year ago:

President Charlie Meyer called the May HCRTA meeting to order at Oberhaus Park. New members Joe and Janet Aschemeier were announced. Anne Rausch reported that about 30 teachers attended the retirement planning seminar held in April. Rose Wiemken, President of the Henry County Historical Society, shared information about the society which was formed in 1970.

The Red Poppy - Bonnie Edy



Hopefully, spring is finally here to stay. I've actually been able to work outside the past couple of days and put plants into pots. The hostas are finally up, but not all leaves are completely open. Everything has been late in coming

up by two to three weeks. Two of the flower beds are full of poppies that will have red blooms by the end of the month. Do you remember what is special then? Answer – Memorial Day. Do you know what artificial flower is distributed by the American Legion Auxiliary

in exchange for donations? Answer – the red poppy.

The history of Memorial Day and the red poppy goes back to World War I and the writing of "In Flanders Fields" by Canadian physician Lieutenant Colonel John McCrae. On May 3, 1915, inspiration for writing that poem came after he presided over the funeral of his friend Alexis Helmer who died in battle. The poem was first published on December 8, 1915. It still is one of the most popular poems from WW1. The reference to the red poppies that grew over the graves of fallen soldiers led to one of the most recognized memorial symbols for soldiers who died in wars. In the US, the Veterans of Foreign Wars conducted the first nationwide distribution of remembrance poppies before Memorial Day in 1922.

Brooke graduated from Miami University with a major in Early Childhood Education and is teaching 2nd grade for the Anderson Township Forrest Hills School District near Cincinnati, Ohio. Griffith Family Book Grant: for residents of Henry County who are or are planning to major in education. The \$500 book grant from this fund is awarded to full-time undergraduate students wishing to obtain a Bachelor's Degree in Education. Preference will be given to a new (freshman) college student from Henry County, Ohio. If no one is eligible, the committee may use discretion for students already enrolled in an education degree program. Griffith Book Grant applications must be submitted by April 1.

Lucille and Margaret Sherman Book Grant: Residents of Henry County who are college juniors majoring in education are welcome to apply. This \$500 book grant is available through the HCRT Foundation. The Sherman Book Grant applications must be submitted by June 1.

Roger King Book Grant: for a graduate of Napoleon High School who was a member of the band or choir. Note from the President....

Another school year is drawing to a close and it is time to award book grants to worthy students planning a future as educators. What kind of future do they face? Is teaching for a new “greenhorn” anything like we remember when we were in the classroom? Will new teachers experience the joy of interacting with and watching children learn? We retired teachers are lucky! We have been blessed with many fond memories of the fun filled times we spent with students under our care.

Teachers in today’s the classroom face an entire different world than what we experienced as educators. The Standard Aptitude Test (SAT) and the American College Test (ACT) were the only professional testing I can remember that students faced during their educational life. Yes, we administered semester exams and final exams for each class during high school and had chapter tests, etc. during upper elementary school ... and all of us experienced weekly “spelling tests” during the early elementary school years. But times have changed!

Competency Testing is now the tail that wags the educational dog. What has become of the ability of a teacher of evaluate the daily, weekly, or “6 weeks grade card” progression of students as they move through the educational process? After completing a high school course, why is a “final examination” no longer considered a sufficient indicator of mastery of that course’s objectives?

Because of the huge emphasis government has placed on educational competency test results, teachers are forced to “teach to the test” to get their students ready for testing. Failure to pass the proficiency test not only labels the student but is also a negative mark against the teacher for not meeting the needs of his/her students. In some proposals, teacher evaluations are partially based on their student’s success on competency tests. The pressure on educators to develop successful test takers has made teaching less enjoyable and more arduous. My recent conversation with a fellow teacher who is retiring after 44 years of experience stated that “teaching isn’t fun anymore like it was years ago because of all the hoops we have to jump through”.

In today’s Toledo Blade, an article announced “Kindergarten show canceled so children can keep studying”. An annual year end two-day kindergarten show has been cancelled at a New York school because the children have to keep working so they will be “college and career” ready. Kindergarten and even preschool has become academic, at the expense of recess, and the arts, in this era of standardized test-based school reform.

In a recent poll rating the top 200 jobs in America for 2014 based on work environment, stress, and hiring outlook, the following may show the effects of what is happening to the teaching field. A janitor was rated #97; an Elementary School Principal was rated #99; and an Elementary Teacher was rated #117; Rated #118 was a maid and #119 was a carpenter.


