The three students are this year's recipients of HCRTA Book Grants. President Meyer also introduced Bob Hall, guest speaker for the evening. President Meyer then offered the table blessing before the evening meal.

Following the meal, the business meeting was called to order. The secretary's report and treasurer's report were given and approved as presented.

#### **Committee Reports:**

Courtesy South: Sandy Honemann reported sending Fourth of July cards to members.

<u>Retirement Planning</u>: Gregg Merrill reported that information is being gathered to be given to educators who may be on the fence about the retirement decision, so that they may make an informed choice about this important life decision.

<u>Webmaster:</u> Karen Brubaker reminded members to send photos to her as a jpg file and she would be able to post them on the website.

<u>Historian:</u> Faith Hurst reported receiving news clippings from Doris Ruby and encouraged all members to continue to watch for articles to submit for the historical records.

#### **Old Business:**

President Meyer encouraged members to become personally involved in taking the dictionaries to the classrooms to see firsthand the positive reactions of the students as they receive their books.

Several birthdays were accidentally omitted from the newsletter posting this month. A list of corrected birthdays was available to members if they wanted.

The 50/50 drawing was held, with Larry Vocke as the winner. He generously donated his winnings back to the fund.

The business meeting was then adjourned and Vice President Nancy Hoover introduced the guest speaker for the evening, Bob Hall. He spoke to the group about his involvement with a new business venture, Black Cloister Brewery, to be



located in Toledo. Bob has been home brewing beer for about 40 years. He gave an interesting history of brewing and told the group about the business plans for the new company and how he had become interested in being involved with them. Bob has also been in charge of the beer and wine competition at the Henry County Fair and told the group that last year 100 wine and 40 beer entries were judged at the Fair.

#### Note from the President....

Another school year has begun and students, teachers, and school personnel are "back in the saddle." Whatever became of the three months of summer vacation

we as youth experienced? Probably the same as the 12" TV, wringer wash machines, and fender skirts on our cars.

An "old friend" Ralph Roshong, my boss and high school principal at Wauseon during the mid-60's, recently sent me an interesting article about Ohio school funding and the amount of local levy funds that go to the Ohio charter school industry. I wish to share the article with you.

"In school year 2013-2014, nearly one-half billion dollars in local levy funds went to the Ohio charter school industry.

In the school year 2013-14, Ohio school districts had \$896,440,995 deducted from their budgets for 121,825 charter school students over which elected boards of education had no governance regarding their curriculum, programs, services, academic ratings, graduation rates, etc. The charter school industry is a publicly-funded private school enterprise.

School districts received \$466,918,677 from the state for those 121,825 students and paid

out \$896,440,955; hence the difference of \$429,522,278 came from local tax levies. State officials have, in vain, attempted to convince the public that charter funding is state money only.

588 school districts (96%) receive less total state calculated per pupil funding than they pay out per pupil to charter schools. On the average, school districts receive \$3832.70 per pupil in total calculated state funding and pay out \$7358.43 per charter school student.

School district levies must be used in accordance with the stipulation of items indicated in the board-adopted resolution. Since support for charter schools is not one of the stipulated items, local tax funds should be disallowed for charter school students. Only the state money a district receives should be transferred to charterville.

This is an issue that needs to be litigated."

I'm sure there are very successful charter schools out there that meet the needs of numerous students, especially since public education has all but eliminated areas such as industrial technology, modern homemaking, etc.

But if these schools are receiving tax monies, they should be held accountable just as our public schools must account to the governing bodies.

#### **Community Service and Volunteer Hours**

The HCRTA had only 20 members report 1482 hours of volunteer time to the communities of Henry County this past time period. We have a goal of 10,000 hours of service this year and have a total of 4052 hours thus far reported. I know there are more than 20 of you that do volunteer work. Please keep track of your hours and use one of the convenient ways to report them.

Retired teachers make wonderful volunteers. It offers a service to our community, makes this organization look good, and gives you the

satisfaction of helping other residents and community organizations out.

#### Fall Is On Its Way - Bonnie Eddy

Fall is on its way. Is fall your favorite season? I often hear people say that it is. My initial reaction is that it's not my favorite because winter will follow. And then I tell myself that I should be positive and think of the good things fall brings. Many people would list football at the top of their list. My list is fall flowers and spring bulbs and flowers to plant.



Fall flowers that are beginning to bloom are the mums. Others that have been blooming are the hosta flowers, cannas, geraniums, helianthus, butterfly bushes, and amaryllis. I did an

article before regarding the mums, so I'm going to challenge you to make something for your front door. It's called a wreath. You can use fresh flowers, dried flowers, or silk flowers. Silk flowers, of course, will last forever.

I'm sure of that because of something I did recently. I had purchased at the HC Senior Center a puzzle of nine kittens side by side that measures 36" wide and 12" tall. It was saved by gluing it to a cardboard back. I then took it to Johnson's Country and Ice Cream Shoppe where Peggy and I selected the frame and mat that Phil would frame around the picture. When I brought it home, the big decision was where to hang it. Decision made meant taking down the first wreath I ever made with both fresh and dried items. Because it hung in the kitchen all those many years, everything became dried. As I took it down, it decorated the floor with most of the dried 'stuff.' It has now been 'put to rest.'

Most wreaths are round, but you can make other choices such as diamond shape or square. There are choices of metal or straw for a backing. You will need thin wire to wrap around the flowers and other additions to the wreath. If it's for the Christmas



season, you may want to add Xmas bulbs and silk poinsettias. If you're aiming for Halloween, think of things that are related to that, such as ghosts and pumpkins. If you're aiming for Thanksgiving, how about pumpkins and other fruits, plus mums. Ribbon bows always add to the finished product. You decide if you

want to add one or more.

Are you thinking that you can't make a wreath? Then call a friend or family member to help. Many times it's said that more than one person working on a project creates an outstanding project. Give it a try.

The other fall project I always find myself doing is planting spring bulbs. When I say 'bulbs,' do you think only of tulips, daffodils, narcissus and hyacinths? I already have those planted throughout the gardens, so now I'm looking at amaryllis in pots for Christman I'm

for Christmas. I'm considering planting more bulbs and plants such as oriental lilies, Chinese trumpet lilies, more Asiatic lilies, more peonies, and more hardy geraniums. You are welcome to come help plant these. The exercise will be good.
