



President Shrider introduced a football theme to determine the order of dismissing to the serving table. Blessing was offered and a delicious meal of meatloaf and trimmings was enjoyed by all.

Following the meal, the business meeting was called to order. The Secretary's report was accepted as written and the Treasurer's report was also accepted and filed for audit.

Committee Reports:

Medicare Alert from ORTA

Becky Shindler, our HCRTA legislative liaison, asked us to forward this information to all HCRTA members. It comes from the Ohio Retired Teachers Association.



On October 15, the Social Security Administration officially announced for only the third time in the 40 year history of Social Security (2010, 2011, and 2016) there will be no COLA increase for SS benefit recipients in 2016. The COLA is tied to the Consumer Price Index (CPI) which has been flat due to lower gasoline prices. The lack of a raise triggers other bad news for some retirees---higher medical costs.

Most Americans have their Medicare B premium deducted directly from their Social Security checks and the COLA increase usually covers any increase to premiums. When it doesn't (like in 2016), a "hold harmless" law protects those roughly 70 % of seniors from any increase which would decrease their SS benefit check amount.

That leaves about 30% of Medicare B participants who do <u>not</u> receive Social Security benefits and are billed for their Medicare Premium to cover the increase which would otherwise be spread among everyone. New enrollees and Medicare beneficiaries who aren't on Social Security (THAT IS THE MAJORITY OF STRS BENEFIT RECIPIENTS-----US!) — and who do not have high incomes — would thus pay not the

current \$104.90 a month in 2016 but a 52 % increase which would be \$159.30. People in the higher-income premium groups would have similar percentage hikes, from a range of \$146.90 to \$335.70 a month in 2015 to a range of \$223 to \$509.80 in 2016. Additionally the current Medicare B deductible would increase from \$147 to \$233. Public employees in non Social Security states such as Ohio, Texas, California, and New Jersey just to name a few would all be impacted by these increases.

Our members are already paying a Social Security penalty resulting from the Windfall Elimination Provisions (WEP),and/or the Government Pension Offset (GPO) that have been levied upon Ohio's public servants and educators.

Because of the rising cost of health care, our respective retirement systems have had to cut back on what they have historically provided us in the way of benefits. As you may know, many of us accepted lower pay as public servants, because of the promised retirement benefits.

With each passing year, our benefits have been eroded. Any increase to the Medicare Part B premiums would extract an additional financial burden on those of us trying to make do with our modest pension amounts.

NOW is the time to be contacting your Senator or Congressman to urge action to prevent this huge increase.
