Henry County Retired Teachers Association Secretary's Report - May 9th, 2016

The Henry County Retired Teachers Association meeting for May was called to order by President Charlotte Shrider. Following recitation of the Pledge of Allegiance, President Shrider welcomed guest speakers Adam Tracy and Kelly King from Children's Lantern. A moment of silence was observed for members who had passed away since our last meeting: Lu Alexander, Eleanor Engler, Carol Sonnenberg and Mary Lou Mengerink. President Shrider then asked volunteers from each table to hold signs with the names of songs that had flowers in their title. These were arranged in chronological order as to the year they were introduced and the tables were dismissed to the serving line in that order. President Shrider offered the prayer and a delicious lunch of Chicken Alfredo and sides were enjoyed.

Following the meal, speaker Adam Tracy gave a very informative talk on human trafficking and foster care. Human trafficking is a very real problem in our rural area, not a situation that is limited to the big cities. Adam gave brief definitions of trafficking and told us how his agency works to rescue victims from that life. He also talked briefly about the foster care system. He and his wife have personally taken in foster children, some of whom they have later adopted into their family. We all learned a great deal about a very difficult subject. For anyone wishing to know more, handouts were available with more information.

The business meeting was then called to order. The secretary and treasurer's reports were approved as presented.

Committee Reports:

<u>Courtesy:</u> Marlene Jones reported sending several cards, including to the families of members who passed away.

Legislative: Becky Schindler advised members to be alert to issues with health care. When paying bills to doctors, be sure that you are not being billed double for the same visit. Proposed vouchers for Medicare/Medicaid were discussed.

Membership: Nan Bretz asked members to continue to forward names to her of retired teachers to invite to join.

<u>Community Service:</u> Tom Jenny encouraged members to continue to report the hours they volunteer.

<u>Webmaster/Newsletter:</u> Steve Seagrave encouraged members to sign up for email alerts from STRS, to help keep abreast of the most current issues. Anyone who has not given their email address to Steve for the HCRTA Newsletter is encouraged to do so.

<u>Historian</u>: Faith Hurst thanked Doris and Mary Jane for giving her articles this month.

Educational Foundation New Foundation President Terry Witt read a Thank You note from Drew Garringer for the grant he received. She then asked members who may be interested in being readers for the next round of applications to give her their names. The committee would like to generate a list of members willing to help with this task if needed.

Steve Seagrave then went over the proposed changes in the bylaws of the Foundation. After explaining each of the proposed changes, he moved that they be approved by the membership. Bill Lytle seconded. The motion was passed.

Note: A copy of the bylaws proposals and the changes implemented are filed with the foundation secretary.

Old business: President Shrider reported on her attendance at the ORTA conference. She learned many things. One fact that impressed her was the vast number of retirees being served by STRS in Ohio and the money being spent each year for health care and pensions for those retirees.

It was reported that \$75 was collected at the last meeting for Habitat for Humanity and \$62 for Together We Can Make A Difference. The money for TWCMAD will be put toward their tutoring service.

New Business:

The next meeting will be on July 11th at 5:30. It will be a potluck dinner, with our book grant winners and their parents invited to attend. There will also be a white elephant auction, a fun way to raise funds for the group and our charities, so be sure to find some interesting items to donate for sale and/or bring your money ready to bid!

Garden Time

The calendar may not say it's summer, but working outside with the plants that are all up and getting rid of the weeds tell me otherwise. We have pathways between our beds and like to put the free mulch we get at the city dump on the pathways. We also put the mulch around the plants in the beds of flowers and plants. We still have lots to do. I can't believe that some of the hostas have buds

already. We are really enjoying the daylilies that have started blooming and can see the many buds that are there. We're been hostaholics for a long time and now I've started using the title of daylilyholic title to my involvement with daylilies. I think it's great that research has produced daylilies that bloom more than once. You may remember that I had lots of plants for sale at our May meeting and our Foundation fund is \$100 richer.

Four new plants that we got last year are the hibiscus. One of the four is shrub size, and the other three have trunks that are about two foot tall before the branches begin. All four bloom all summer long with single, beautiful, red flowers. These plants are annuals and we pot them in the fall and bring them into the house. They also bloom while inside the house.

When we built our house and the children were home, we had a big veggie garden at the back of the lot. We picked and froze and canned the veggies for winter use. We still had the veggie garden after the kids left until the morning I went out to pick the green beans. The deer had beat me there and eaten both the beans and plants. That was the end of the veggie garden. By then we had started to be interested in hostas so we built lattice covers and now have all that space filled with hostas and other shade plants. We move our couch in the living room during the summer months so we can enjoy looking out to the back yard that includes the hosta beds that are in front of the window. We have lots of hostas in other shade areas. We are active members of the Black Swamp Hosta and Daylily Society that meets at the Toledo Garden Center each month, plus take a couple of their trips that go to big hosta centers. Hostas also are on each side of the sidewalk that comes up to our front door. Hostas also grow in front of the stone wall at the front of the house.

We had had over a hundred tea roses for many years and never replaced any of them as they died one by one. Almost all of those roses were gone by the time the single Knockout rose was introduced several years ago. Walmart put them on sale at the end of the first season so I bought a couple. Then when they were reduced again, I bought a couple of more. By the time the sale season was finished, I had purchased eight roses. They easily survived the winter and we've had them at the front of the back garden ever since. The next year the double red Knockout was introduced and I bought twenty-two of them with eight planted in the bed in the middle of our U-shaped driveway and fourteen of them planted in front of the tub room windows. The next year pinks were introduced and I bought double pinks and they are planted in the round flower bed in front of our garage. I didn't like the yellow Knockouts that were introduced the next year and, of course, purchased none of them. There was also a pink/white one introduced that I didn't buy. Last year the white Knockout was introduced and I bought four of them that are planted in the center of the U-shaped driveway. I love these beautiful roses that require very little work.

You are all welcome to come visit out gardens. Just call 599.5795 before coming to make sure we're home. I'll also have a gift hosta to send home with you. We love having visitors.
