# Henry County Retired Teachers Association Secretary's Report – March 13, 2017

The Henry County Retired Teachers Association meeting for March was called to order by President Charlotte Shrider. Following recitation of the Pledge of Allegiance, new member LeAnn Kraft and guest/prospective new member Diane Meyer were recognized.

With March Madness in mind, names of basketball teams from the Big Ten were found on the tables and helped determine the order for dismissal to the buffet table. Prior to the meal prayer, a moment of silence was observed in memory of Bonnie Eddy, who passed away since our last meeting. Following an Irish prayer given by Nan Bretz, all enjoyed a meal fit for a leprechaun, consisting of corn beef and cabbage, various sides and appropriately green decorated cupcakes.

Nancy Helmke then spoke to us about Orphan Grain Train. The organization was started by a minister from Nebraska after a trip to Latvia and Russia. They have helped people in more than 40 countries. Volunteers gather clothing, household goods, furniture, cleaning supplies, books and many other donated items to be given to victims of natural disasters such as floods, hurricanes or tornadoes. They also supply these items and more to poverty stricken populations in several locations, many not that far away from Northwest Ohio. They work in tandem with the Red Cross and other agencies to determine need and to help with the distribution of the items. Donations are welcome, as Nancy indicated that they are collecting 365 days a year. Donations are tax deductible. Anyone with time to donate was encouraged to contact Nancy and she will gladly put you to work!

The business meeting was then called to order. The secretary's report was approved as amended (name correction) and the treasurer's report was approved as presented. President Charlotte reported that the books had been audited by Marv Barlow and all was found to be in good order.

### **Committee Reports:**

<u>Courtesy:</u> Marlene Jones and Sandy Honemann were both present to catch us up with concern for members. Cards were sent to Bonnie Eddy when she was ill and sympathy was subsequently extended to her family upon her passing. Jackie Sautter has a new room at Fairlawn in Wauseon and would love visitors. Cards were sent to Doris Ruby to celebrate her recent 95<sup>th</sup> birthday. A Thinking of You card was sent to Rosemary Pfau and she responded with a phone call to say she appreciated the thoughtfulness.

<u>Legislative:</u> Becky Schindler relayed information provided by Dennis Leone concerning COLA. Members were urged to pick up copies of the information and to study the impact of past changes and proposed changes to the COLA benefit.

<u>Membership:</u> Nan Bretz again welcomed new member LeAnn Kraft and guest today, Diane Meyer.

Retirement Planning: At the February Executive meeting, a discussion was held concerning whether there is further need for this committee, since active teachers seem to have more information about retirement planning already and are not showing interest in attending meetings on the subject. As discussion continued, it was decided that perhaps a study be made of all committees, to perhaps make changes. Greg Merrill and Steve Seagrave had volunteered already to take on this task, to study the changes that would be necessary in the constitution if committees are to change or be dropped. President Charlotte asked for other volunteers and Jan Schlade was added to this group.

<u>Community Service:</u> Tom Jenny again had slips on each table for members to fill out volunteer hours.

**Education Foundation:** Terry Witt presented the annual report of the HCRT Foundation. Sandy Honemann was proposed as a new member of the

board. A motion to accept her appointment was made by Rosalie Ashenfelter, seconded by Greg Merrill. Motion passed. Terry outlined the business of the Foundation during the past year and had handouts available with details on the meetings held, as well as information sheets describing the grants available. She reported that she had made personal contact with school guidance counselors and hopes that this will increase the interest in grant applications. Gene Grime went over the finances of the Foundation, with handouts also available for members with the information.

Old business: President Charlotte reported that due to not having a meeting in December, she had to make some decisions for the group concerning the caterer and the location of meetings. The executive board discussed these items as well. We will continue with Marc Matheny as caterer. The price for the meals was raised to \$11, so at the Executive meeting, it was decided to raise the fee for each meeting to \$13, with the extra two dollars going toward rent of the building and other group expenses. We will continue to meet at Oberhaus Park. We will also continue with Together We Can Make A Difference as our charity. Habitat for Humanity was a one year project and contributions will not be continued this year.

At the Executive meeting, it was also decided to try "tip jars" on each meal table as an additional way to raise funds for the group. It is hoped to establish a speaker's fund.

President Charlotte reminded all members that once a meal reservation has been made, it must be paid, even if you are subsequently unable to attend. The group must pay the caterer for meals ordered, so unless you have a cancellation before the number is turned in to the caterer, you are obligated for that cost. If you arrange for someone to take your place ahead of time, that will be accepted, but in fairness to all we will no longer accept substitutions on the day of the meeting.

A sign-up sheet was passed around for volunteers for set-up and host/hostess committees.

<u>New Business</u>: Steve Seagrave had a few extra directories available for sale. The price is to cover the cost of printing and binding. Steve was thanked for his work on the directories and the newsletter.

Throughout the meeting, President Charlotte drew names for door prizes of lottery tickets. The winners were Becky Chamberlin, Larry Vocke, Greg Merrill, Gene Grime and Diane Meyer. Hope they all hit it big!

Nancy Hoover was the winner of the 50/50 drawing.

# **HCRT Foundation Annual Report 2016**

Presented at the HCRTA Meeting, March 13, 2017

The HCRT Foundation has met three times since the general meeting last March. Our most recent meeting was held on Monday March 6, 2017. This was our organizational meeting, and we selected officers for the 2017-2018 year.

The board members for 2016 were: Becky Chamberlin-agent; Gene Grime-treasurer; Terry Witt-president; Jan Schlade - vice-president; Steve Seagrave - secretary; Linda Wagner-member. Jerri Osborn concluded her term on the board and as president of the board. Sandra Honemann will join us as the 2021 member.

Treasurer Gene Grime will provide copies of the financial report, and it will be in the next newsletter.

The history of the Foundation has been updated, adding the names of the Book Grant recipients for 2016: Drew Garringer - Griffith recipient; Allison Lamming- Brubaker recipient; Madlyn Dishop - Sherman recipient; Michaela Jones - King recipient. We had an increase in the number of well qualified applicants for all four Henry County schools.

All four grants are in the amount of \$1000. Information about the Griffith Grant, which is due April 1<sup>st</sup>, has been delivered to the guidance departments of all 4 high schools. There will also been information in the newspapers of the county, WNDH, and the Defiance Crescent, which gives us contact with the families of students, who are no longer in high school. The deadline for the other 3 grants is June 1<sup>st</sup>, and that information will go out at the beginning of April. I will be sending letters to all the recipients and applicants from last year, inviting to apply again if they are still eligible. There are handouts available today if you would like to post them at your church or other location, or if you know any students pursuing education as a career. We have awarded 41 book grants, totaling nearly \$22,500, since 1998. Remember, you may contribute to the Foundation at any time by sending donations to Gene Grime.

Please continue your efforts to get the information out that these grants are available. Personal contact has been a very effective tool to increase the number of well-qualified applicants who have participated in recent years.

#### Who Was Haym Solomon?

(Editor's Note: Bonnie had sent this to me last year to use for the newsletter. I was not able to use it till now.)

Read this fascinating history of the \$1 bill – all the way to the bottom to know about <u>Haym Solomon</u>. You may be in for quite a surprise!


On the rear of the One Dollar bill, you will see two circles. Together, they comprise the Great Seal of the United States. The First Continental Congress requested that Benjamin Franklin and a group of men come up with a Seal. It took them four years to accomplish this task and another two years to get it approved. If you look at the left-hand circle, you will see a Pyramid.

Notice the face is lighted, and the western side is dark. This country was just beginning. We had not begun to explore the west or decided what we could do for Western Civilization. The Pyramid is uncapped, again signifying that we were not even close to being finished. Inside the Capstone you have the all-seeing eye, an ancient symbol for divinity. It was Franklin's belief that one man couldn't do it alone, but a group of men, with the help of God, could do anything.

THE UNITED STATES OF AMERICA

#### 'IN GOD WE TRUST' is on this currency.

The Latin above the pyramid, ANNUIT COEPTIS, means, 'God has favored our undertaking.' The Latin below the pyramid, NOVUS ORDO SECLORUM, means, 'a new order has begun.' At the base of the pyramid is the Roman numeral for 1776. (MDCCLXXVI)



The Bald Eagle was selected as a symbol for victory for two reasons: First, he is not afraid of a storm; he is strong, and he is smart enough to soar above it. Secondly, he wears no material crown. We had just broken from the King of England. Also, notice the shield is unsupported. This country can now stand on its own. At the top of that shield there is a white bar signifying congress, a unifying factor. We were coming together as one nation. In the Eagle's beak you will read, 'E PLURIBUS UNUM' meaning, 'from many - one.' Above the Eagle, we have the thirteen stars, representing the thirteen original colonies, and any clouds of misunderstanding rolling away. Again, we were coming together as one.

Notice what the Eagle holds in his talons. He holds an olive branch and arrows. This country wants peace, but we will never be afraid to fight to preserve peace. The Eagle always wants to face the olive branch, but in time of war, his gaze turns toward the arrows.

An (untrue) old-fashioned belief says that the number 13 is an unlucky number. This is almost a worldwide belief. You will almost never see a room numbered 13, or any hotels or motels with a 13th floor. But think about this: America, which relies on God (not a number) to direct and lead, boldly chose:

13 original colonies,13 steps on the pyramid,13 bars on that shield,13 signers of the Declaration of13 letters in 'Annuit Coeptis',13 leaves on the olive branch,Independence,13 letters in 'E Pluribus Unum,'13 fruits, and if you look closely,13 stripes on our flag,13 stars above the eagle,13 arrows.

And finally, notice the arrangement of the 13 stars in the right-hand circle. You will see that they are arranged as a Star of David. This was ordered by George Washington who, when he asked Haym Solomon, a wealthy Philadelphia Jew, what he would like as a personal reward for his services to the Continental Army. Solomon said he wanted nothing for himself, but he would like something for his people. The Star of David was the result. Few people know it was Solomon who saved the Army through his financial contributions...then died a pauper. Haym Solomon gave \$25 million to save the Continental Army, money that was sorely needed to help realize America's – our- freedom and independence from England. Therein lies America's Judeo-Christian beginning.

Most American children do NOT know any of this. They are not taught because their history teachers do NOT know this. They were not taught on America's Freedom.

Too many veterans gave up too much to let the meaning fade. Many veterans came home to an America that did not care. Too many veterans never came home at all. They served, they died <u>for you</u> ... <u>for me</u>.

I hope you will share this page with many-so they can learn about the UNITED STATES DOLLAR BILL, and what it stands for. America is at a critical juncture. Let's do *whatever we can* to save her while never, ever forgetting: It is God in whom we put our trust!
