NEW BUSINESS

- <u>Bylaws</u> Steve pointed out that in the bylaws the membership on the board is addressed and includes five voting members in rotating five-year terms. We have traditionally had an "agent" of the corporation as outlined in the incorporation papers but this position is not mentioned or clarified in the bylaws. In addition, the treasurer has traditionally been a voting member of the board but not one of the five members whose membership on the board expires. This is not currently addressed in the bylaws and needs to be clarified. Also, the position of "ex-officio" or honorary members of the board is not addressed in the bylaws and we do have an ex-officio member, Doris Ruby. The appointment and use of ex-officio members needs to be addressed in the bylaws. The board also needs to have authority to bring in non-voting members to assist the board and to fill positions in the case of incapacitation. Steve will work on draft proposals and email them to board members for feedback and suggestions.
- <u>Audit</u> Gene pointed out the need to have an audit of the books. The bylaws require this each two years. Terry will arrange for someone to audit the books. It may be necessary to pay for the service since out finances are now more complicated.
